Correspondence

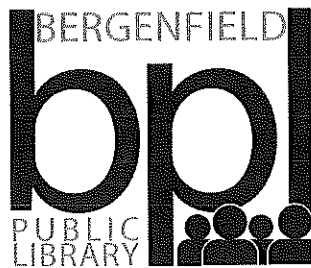
A request was received from Helen Siciliano to use the facilities for weekly game nights on Thursdays in December for teens.

He shared the concert was well attended and that Kristie Murru did a great job hosting the event. Ms. Shaffren recommended sharing publicity from the event to promote this community event.

The Datacom company has done a temporary fix so we can receive and make calls while waiting on Verizon. Ms. Ballo reported that PSE&G has started billing us for the lighting and HVAC work done earlier this year under the Direct Install plan.

Finance Committee

The financial summary was distributed and discussed. Options for the maturing CD at NVE Bank were discussed. Due to the potential of utilizing the funds for a future construction project, liquidating the funds for deposit into the capital account was discussed.

Old Business

The revised Personnel Manual was revisited. Discussion followed.

A motion was made by Ms. Cruz-Betesh, seconded by Ms. Phipps, to approve the revised Personnel Manual effective January 1, 2022 with a few minor changes to wording as discussed. All in favor. Motion carried.



New Business

President Neats reported that copies of the 2020 Audit Report were delivered to the Trustees and there were no recommendations from the auditor.

The 2022 proposed Operating budget was distributed by mail and discussed. This proposed budget reflects a 2.8% increase in overall expenses which takes into account minimum wage and contractually negotiated raises. Increased revenue is anticipated from the Library's passport program and offsets some of the overall increase.

A motion was made by Ms. Cruz-Betesh, seconded by Ms. Rivas recommending Ms. Ballo submit the proposed 2022 Operating Budget to the Borough. All approved. Motion carried.

Ms. Ballo discussed the timeline for the Lucille Tendler award and the Board agreed to keep it the same as in the past.

Adjournment

A motion was made by Ms. Phipps, seconded by Ms. Chittum, to adjourn the meeting. Meeting was adjourned at 8:42 pm.

ANNUAL REPORT – 2021
CHIEF'S COMMENTS

As we look back on 2021, the following pages is the yearly report prepared and submitted to provide the residents and taxpayers of Bergenfield a synopsis of what their police department has responded, handled, and investigated during the past twelve months. The department strives to always provide the best police services to our community.

Despite unprecedented challenges in dealing with the COVID-19 pandemic during this past year and the manpower shortages affecting the entire department, the PD was tasked with doing more with less as the total calls for service increased from 27,737 in 2020 to 37,967 in 2021. The officers, telecommunicators and civilian personnel of the Bergenfield Police Department always focused on serving the citizens of the borough according to our mission statement. Police administration worked diligently with the intentions of finding ways of reducing costs while improving the quality of services delivered to the residents. In spite of these challenges faced, the PD was able to ensure the safety of our residents while also engaging with the community on several fronts. The PD, with the support of the Mayor / Council conducted its "bike with a cop" event for the second straight year, bringing residents and police together for a friendly ride through town. Reaching out to all ages in our community, the PD conducted presentations on Internet Safety and Opioid Abuse throughout the schools while also conducting an Identity Theft Prevention presentation to our elderly residents. With the support of the Mayor / Council, the PD held a barbeque for our elderly residents.

We will continue to strive towards perfection as we move forward, always remembering the reason of our roles as law enforcement public servants; and that is to serve and protect with dignity and respect. That service is made possible by the work and efforts of the personnel who report for duty each and every day.

Officers patrol the borough and respond to calls for service of varying types conducting preliminary investigations of crimes and incidents, effecting arrests, checking on suspicious activity, making referrals, administering medical aid as first responders and assisting citizens in every way possible. They also enforce state traffic laws and the local ordinances of the borough to make Bergenfield a safer community for all. Officers assigned to the detective bureau conduct follow-up investigations, work on major case investigations and work in conjunction with numerous other police and civilian agencies to solve crimes in our area and assist those in need. The detectives play an important role and assume responsibilities such as, precious metals records checks, pre-employment background investigations, firearms background checks, internal affairs investigations, fingerprinting services, information sharing and agency assists involving numerous law

enforcement agencies in Bergen County, the State of New Jersey, its surrounding states and many federal level agencies as well.

The 911 telecommunicators work the *Communications Center* and receive emergency and non-emergency calls and then dispatch the appropriate resources to those calls for service. Their role is vital as it serves as the first link between the citizen and the officer on patrol. In many instances, the telecommunicators provide emergency aid instructions over the phone to a caller which could mean the difference between life and death.

The civilian personnel of the department also serve the citizens, officers, attorneys and others, by keeping custody of the records of all police documents, data and reports and then organizing the records to have it ready for trial, discovery or for any type of documentation request needed in criminal, civil or personal proceedings. Their role in organizing the archives storage and department's transition to "paperless" record-keeping has been immeasurable.

I cannot emphasize enough that all of our employees are our most valuable resource.

The department remains an accredited police agency through June of 2022. We have rules and regulations that have been adopted by the governing body. Our policies and procedures are in line with the accreditation standards and best practices of modern police organizations. We provide "proofs" to show those standards are met each year. The agency successfully passed reaccreditation in early 2019. In April of 2022, we will again undergo a professional evaluation from two State Assessors to ensure we are in compliance with the standards set forth by the New Jersey State Chiefs of Police. From the NJSACOP (New Jersey State Association Chiefs of Police) website on Accreditation:

Accreditation is a progressive and time-proven way of helping law enforcement agencies calculate and improve their overall performances. The foundation of Accreditation lies in the adoption of standards containing a clear statement of professional objectives. Participating agencies conduct a thorough self-analysis to determine how existing operations can be adapted to meet these objectives.

Our Police Officers are held to the highest standards and receive the highest levels of training in the state. That training includes ethics, bias awareness training, cultural diversity, proper use of force, de-escalation techniques, and mental health awareness. Training / Education is a never-ending process which we continually pursue in order to meet the highest standards that our community deserves.

I would like to express my sincere thanks and appreciation to the governing body for their continued support and confidence in me as the Chief of Police. It's been an honor for me to hold this position and a challenge that I always seek to improve upon. There is no one person more important than the other. Together, we can achieve great things. I look forward to working with the council in 2022 to provide the borough its best possible police services. The diversity in our community is our strength and I look forward to engaging with our community and building upon our community-based policing. The police department strives to provide the best services to the citizens of Bergenfield 24-hours a day, 7 days a week.

This annual report is a compendium of data and statistics compiled by the various bureaus within the police department. Although the annual report is a useful and informative tool, it is only a brief summary of all the work conducted by the sworn officers and civilian employees of the police department every hour of every day. No document of this type could ever measure the service that these men and women provide to the citizens of our community.

YEARLY REPORT 2021

PATROL BUREAU

Members of the Patrol Bureau responded to a total of thirty-seven thousand nine hundred and sixty-seven (37,967) **Calls for Service** for the year. They effected seventy-eight (78) **Arrests** for Criminal, Motor Vehicle Offenses and/or active FTA-Traffic/ACS Criminal Warrants

Patrol Officers also investigated seventy-nine (79) **Domestic Violence** incidents, thirty-four (34) **incidents of Criminal Mischief**. There were eighty-seven (87) **Thefts** (from motor vehicles, bicycles and other cases).

There were four (4) **Missing Persons** reported to our Department. Preliminary investigations were conducted for one hundred and forty-two (142) **Identity Theft/ Fraud** cases. They also completed two hundred and thirty-two (232) **Resident Welfare** checks, six hundred and eighty-five (685) requests for **Assistance** and eighty-seven (87) requests to make **Notification** to residents.

Patrol Officers issued a total of one thousand one hundred and sixty (1,160) **Summonses** for Motor Vehicle Violations. They had one hundred and seventy-six (176) vehicles **Impounded** for violations.

Officers responded to and completed crash reports for six hundred and fifty-three (653) **Motor Vehicle Crashes**. They also received one thousand five hundred and twenty-three (1,523) requests for **Medical Aid**, and one hundred and twelve (112) **Mental Health** matters. There were five hundred and seventy-four (574) **Alarm Activations** and six hundred and eighty-four (684) reports of **Fire**.

Additionally, Patrol officers responded to and investigated eight hundred and forty-nine (849) **Suspicious Incident** calls, five hundred sixty-six (566) **Dispute/Harassment** calls, three hundred nineteen (319) **Noise Complaints/Other Disturbance** calls, two hundred and thirty-one (231) **Animal Complaints** (loose animal, animal bite) calls, one hundred and thirty-eight (138) **Utility Emergency** calls and conducted sixty-eight (68) **Escorts**..

All Officers continued **Security Checks** and walk-throughs of all schools, parks, banks and businesses within the Borough.

Records Bureau Annual Report - 2021

The Records Bureau had a productive year in 2021. The Records Bureau recorded two hundred eighty-seven (287) pieces of evidence, while returning twenty-six (26) items to their owners.

During 2021, the Records Bureau covered twenty (20) Patrol shifts and two (2) Supervisor shifts.

The Records Bureau assisted the Traffic Bureau with Traffic control and security for the following Borough events:

- Veteran's Day Ceremony
- Funeral escorts (2)
- Bergenfield's Bike Event
- Walk Out on Drugs

The Records Bureau upgraded the department computers and all police fleet computers with updated security software (Windows 10) as well as the new LawSoft CAD version / software.

A member of the Records Bureau assisted with interviews and the hiring of one (1) new telecommunicator.

The Records Bureau updated all department computers with Symantec Virus Protection.

The Records Bureau obtained and implemented new training for all telecommunicators and desk supervisors and upgraded the telecommunicator chairs.

The Records Bureau updated Administrations computers with web cams and remote access.

The Records Bureau worked closely with our vendors (GTBM, KML, Lawsoft, InfoCop and Richtco) to maintain our Police CAD, 9-1-1, Police Dispatch, internal network, patrol vehicles, and borough cameras.

During the past year, the Records Bureau continued the process of revising and updating policies and procedures.

The Records Bureau completed semi-annual inspections of the Evidence Room, its Annual Audit as well as an unannounced inspection. All audits and inspections were completed without incident as all items were found as logged in the Beast.

In 2021, the Records Bureau completed numerous expungements as well as assisted with hundreds of Discovery requests.

The Records Bureau worked with GTBM/WatchGuard for the purchase of required Body Worn Cameras, updated servers and computers.

The Records bureau assisted with the installation of new phones for the department (Mitel).

In 2021, the Records Bureau collected three hundred ninety-one (391) pounds of discarded medicine from Project Medicine Drop for destruction.

The Records Bureau renewed its contract with Eventide and its awaiting updated training on the system.

Traffic Bureau Annual Report - 2021

The Traffic Bureau saw an unprecedented year again, as Covid-19 has hampered a lot of our programs and production. Department-wide, the summons totals were One Thousand One Hundred and Sixty (1,160).

The Bureau continued to coordinate traffic control and security for the following Borough events that occurred during the pandemic:

- Dining Under the Stars
- Memorial Day Ceremony
- Veteran's Day Ceremony
- Tree Lighting in Coopers Pond
- Holiday Lights Parade
- BHS events and Graduation
- Bike with a Cop Event
- Assisted with Covid-19 vaccine distribution

In addition to the above, the Traffic Bureau handled traffic control and safety for numerous street construction and utility projects during the year, including NJDOT, Sanzari, PSE&G, Suez, CSX, and Borough Utility projects. It also coordinated traffic assistance for four (4) funeral details, fundraiser projects for local groups and traffic safety for churches and temples during religious holidays and at times provided security.

During the past year the Traffic Bureau continued the process of revising and updating traffic ordinances and related policies and procedures.

The Police vehicle fleet has been refurbished to different degrees either mechanically, cosmetically or both. The Traffic Bureau anticipates replacement of other police units during 2022. The department purchased 2 new Patrol vehicles and a motorcycle in 2021, which are to be patrol ready by 1st quarter 2022. Vehicle designations were changed to provide optimum usage of the vehicles being replaced. In addition to the regular vehicles, the department motorcycles were used extensively throughout the year as was the radar trailer which was used to monitor speed conditions throughout the Borough as well as being used as a signboard to announce special events or conditions to motorists

The Traffic Bureau conducted various road surveys that provided important information regarding traffic volume and speed.

The Traffic Bureau in conjunction with PSE&G Lighting researched and coordinated the replacement of the decorated lamp posts that were missing or damaged along North and South Washington Avenue.

The department participates in many traffic safety and enforcement programs. In addition to conducting limousine inspections, the Traffic Bureau handles the following; motor vehicle enforcement checkpoints, pedestrian crosswalk enforcement details and radar patrols, the Police department also participates in state and federal programs such as the "Click It or Ticket" seatbelt enforcement patrol, "Put the Brakes on Fatalities Day" "You Text, You Drive, You Pay" and the "Drive Sober or Get Pulled Over" DWI patrol. However, during the year of 2021, some of the above programs were suspended due to the global pandemic.

A member of the Traffic Bureau, was reassigned to coordinate and instruct the department annual firearms qualifications. That same member had to also reorder the supply of ammunition that was spent during these qualifications.

The bureau remained active by installing twelve (12) child seats for the Child Seat Safety Check Program. In addition to serving the residents of Bergenfield, department technicians also assisted residents of neighboring towns whose departments no longer had technicians of their own.

During 2021, six hundred fifty-three (653) motor vehicle crashes were investigated. One Hundred Seventy-Six (176) motor vehicles were impounded and One Hundred Forty-One (141) motor vehicles were released from impound.

Currently, there are twenty-one (21) school crossing guard positions that are supervised by the Traffic Bureau. In addition to regular school posts, the crossing guards provide traffic safety for pedestrians at religious services and special Borough events. All of the crossing guards received their mandatory annual training which was held at Bergenfield Police Department in late August.

The Traffic Bureau continues to serve as liaison to various Borough organizations and groups such as the Board of Education, Barrier Free Committee, Site Plan Committee and many of the religious organizations in the Borough. The Traffic Bureau oversees the running of the school safety patrols. There are approximately one hundred ten (110) safeties in the five (5) elementary schools. Each member received training from the school advisor and the Police Department supplied any needed equipment and support material.

In 2021 a member of the Traffic Bureau was recognized for his commitment to his position and was awarded the 2021 Law Enforcement Officer of the Year by Bergenfield VFW Post 6467

In 2021, the Bergenfield Auxiliary Police assisted the Bergenfield Police Department in many ways such as directing traffic, administering medical aid to victims, assisting with crowd control, providing support at motor vehicle enforcement details and security at community events. The men and women of this organization are educated about various police topics and trained at their monthly meetings. However, during this past year the global pandemic hampered many of the aspects of the Police Auxiliary.

Some of the specific events in which the Auxiliary Police have assisted include:

- Parades and Escorts totaling **147 manpower hours**.
- Community events and festivals (Dining Under the Stars, Bergenfield High School Graduation, Tree Lighting) totaling **123 manpower hours**
- Assisted community organizations and miscellaneous patrol totaling **59 hours**.
- The unit additionally completed **87 manpower hours** in training during the year.
- The eighteen members of the Auxiliary Police combined for **416 volunteered hours** to the community.

The Bergenfield Police Detective Bureau's primary function is to conduct investigations regarding criminal activity that are self-initiated, initiated by other components or members of this department, or assigned by a supervisor for follow up or review. Detectives are responsible for conducting various administrative investigations when so directed and for participating in a variety of department programs and activities. In addition, the detectives are responsible for collecting, preserving and processing evidence and for processing crimes scenes when so directed to the extent their training and capabilities will allow.

The Detective Bureau's function will also include narcotics and vice investigations and the investigation of other "quality of life" violations as directed. The Detective Bureau may also be assigned to assist with crime prevention, training, and other administrative investigations, functions, and programs. The Bureau will also monitor the filing of Asset Forfeiture. All Firearms permit applicants will have a background investigation done by a detective. All police employment background investigations will be conducted by the detective bureau. The Bureau will also investigate and be responsible for Fire Investigation and work in conjunction with the Bergenfield Fire Department, and the Bergen County Prosecutor's Office Arson Squad, to determine the origin and cause of any major, suspicious, explosion, or other fire related incidents. The Detective Bureau will also work in conjunction and cooperation with all neighboring municipalities Police or Investigative agencies. Detectives will also work with County, State, and Federal authorities on criminal or administrative matters. The Bureau will be responsible for preparing all search warrant applications. The Bureau will also have assigned two detectives who will also handle Juvenile matters. The Juvenile Bureau is responsible for monitoring Dangerous Stranger, Helping Hand, and the School Fingerprint Programs.

Bergenfield Police Detectives are responsible for conducting follow up investigations as assigned by their supervisors. They will assist the Patrol Bureau when necessary with preliminary investigations. Detectives will patrol and conduct surveillance in the Borough to detect and deter criminal activity and initiate arrests as necessary and will enforce Borough Ordinances. Detectives can be called upon to assist the Patrol Bureau and be assigned to calls of an emergency nature and to back up Patrol Officers when needed.

Detective/Juvenile Bureau
Yearly Report
2021

1. The following is a sampling of the most significant cases during 2021:

January:

One (1) Theft case was investigated and closed. In this incident, a resident reported that a **package was taken** from the front of his residence after being delivered. Through investigation, it was discovered that **two unknown individuals stole the package utilizing a silver SUV**. The delivered package contained items **valued at approximately \$26.00**. With the assistance of the Tenaflly Police, the **suspects were identified and arrested**. **One adult female and one adult male were charged on a complaint summons with Theft** pending their appearance in the Bergenfield Municipal Court. This is case currently **closed**.

One (1) Suspicious Death case was reported and investigated. In this case, Detectives were assigned to assist with a suspicious death incident. Upon the officer's response, it was discovered that a **male victim suffered a medical episode and was pronounced deceased** at a commercial establishment. Upon arriving at the location, it was determined that the male was a **patron of an unlicensed / unregistered massage parlor**. The **Bergen County Sheriff's Department and Bergen County Medical Examiner's Office** responded to assist. The deceased male was **transported to the Medical Examiner's Office, where an autopsy was performed**. It was determined the male died of **natural causes**. **Borough Ordinance Violations** were issued to the female owner / operator for an **Unlicensed Massage Establishment and Unlicensed Massage Practitioner**. This case is **closed**.

One (1) Shoplifting case was reported and investigated. In this case, a **male was observed committing a theft at an Auto Parts Store**. It was reported that the male, who has been a customer of the establishment in the past, entered the store and when the attendant was not looking, the male **proceeded to carry a container of windshield wipers out of the store**. The male was confronted by the attendant, but **fled the scene**. The **total value** of the stolen windshield wipers is approximately **\$204.00**. The male was eventually identified and the male was **charged on a complaint warrant for Shoplifting**. This case is currently **closed pending the arrest of the absentee defendant**

February:

One (1) Identity Theft case was investigated. In this case, Detectives were assigned to investigate a reported Identity Theft. The victim reported that her **information was used to open several unauthorized accounts**. During the investigation, a suspect was identified who resided within the Borough. Ultimately, information and evidence was located, which **uncovered an extensive Identity Theft operation** and **(3) individuals were arrested** and charged on complaints for **various charges, which included Trafficking in**

Personal Identifying Information, Identity Theft, Forgery, Possession of Forgery Devices, Credit Card Theft, Possession of Fraudulent Government Documents, Manufacturing Government Documents, and Possession of CDS. It was also discovered that there were several victims from not only New Jersey, but other states as well. This case is closed.

One (1) Fraud / Theft was investigated and closed. In this case, a jewelry store owner reported that a female purchased several pieces of jewelry, valued at approximately \$1220.00, from the establishment. After a few days, the owner noticed that funds were missing from her account. It was discovered that the female had reported the purchases as fraud and the funds were reversed. The female was eventually identified. The victim requested that the female make restitution in lieu of complaint. Restitution was made to the victim. This case is currently closed.

March:

Three (3) Theft / Criminal Mischief cases were reported and investigated. In these cases, vehicles that were parked throughout the Borough had their Catalytic Converters stolen from the vehicles by unknown actors while parked overnight. The average value for each Catalytic Converter is \$1500.00. These cases are still open and under investigation.

Two (2) Stolen Vehicle cases were reported and investigated. In the first case, a resident reported that her vehicle was stolen from the driveway of her home. The vehicle, which is valued at approximately \$3500.00, was taken during the overnight hours by an unknown actor. The vehicle was reported to be locked at the time of the theft. The vehicle has not been recovered at this time. This case is currently suspended.

In the second case, the owner of a car dealership reported that a vehicle was stolen during the overnight hours from the lot of the business. The vehicle, which is valued at approximately \$55,000.00, was taken by an unknown actor and evidence that the vehicle was entered forcibly was observed. The vehicle has not been located at this time. This case is currently open and under investigation.

One (1) Burglary / Recovered Stolen MV was investigated. In this case, a complainant reported a suspicious vehicle in the area of a business. Officers discovered that the suspicious vehicle, which was unoccupied at the time, was reported stolen from Perth Amboy. Several hours later, it was discovered that the business where the vehicle was located had been burglarized. The unknown actor(s) forced entry into the car dealership window. At the time of the report, nothing was reported missing by the owner. It is believed that the actor(s) of the recovered stolen auto were the same in the Burglary. This case is currently open and under investigation.

One (1) Criminal Mischief / Criminal Trespass case was reported and investigated. In this case, DPW employees reported that an abandoned Borough building had been entered and damage was done. It appeared that Juveniles were the actors and an investigation is currently underway to identify the same. The juveniles were eventually identified and agreed to pay restitution in the amount of \$400.00 for the damages. This case is currently closed.

April:

Two (2) Identity Theft / Fraud cases were investigated and closed. In the first case, a bank within the Borough reported a **suspicious incident** where a female entered and bank and attempted to open an account with what appeared to be a **Fraudulent Pennsylvania Driver's License**. When the female was confronted, **she fled the area**. The unknown female **left the fraudulent driver's license behind**. After investigation, it was **confirmed** that the driver's license was fraudulent and the **actor was identified**. The female actor was **charged on a Complaint Summons with Identity Theft and Possession of a Fraudulent Government Document**. The actor was served with her complaint via mail pending her **appearance in Central Judicial Processing Court**. This case is **closed**.

In the second case, a resident reported that while attempting to make a purchase on the internet from Amazon, she encountered issues and received a message from a "customer service representative". The victim was told that the **"customer service representative" would be able to assist her with unlocking her account if a payment of \$400.00 was made** via a gift card. The **victim complied**, but then realized when the "representative" could not unlock the account that she had been **scammed**. Through investigation, the **actor was identified as a male from Union, New Jersey**. The male suspect was **charged on a Complaint Summons with Identity Theft** and served via mail pending his **appearance in Central Judicial Processing Court**. This case is currently **closed**.

One (1) Theft was investigated and closed. In this case, a resident reported that a package that was delivered to her apartment building **had been stolen**. According to the victim, the package **contained her Government Issued Work Visa**. After investigation, **video surveillance revealed the suspect was a known male**. The male was **charged on a Complaint Summons with Theft and Theft of a Public Record, Writing or Instrument**. The male was served via mail pending his **appearance in Central Judicial Processing Court**. This case is currently **closed**.

One (1) Suspicious Incident / Fraud case was reported and investigated. In this case, a report was received regarding a vacant house being "rented" via a Facebook Marketplace ad. The complainant reported that the "renter" spoke with prospective renters via phone and advised them if they wished to rent the property, to send a \$1000.00 via Zelle as a deposit. The property is currently owned by the bank and is not being rented. This case is currently **open and under investigation**.

May:

One (1) Terroristic Threat / Extortion case was investigated and closed. In this case, a victim reported that he **received numerous text messages** from unfamiliar phone numbers stating that **if he did not send an unspecified amount of money** to a specific number, **the actors would harm his family**. During the investigation, information was obtained that the text messages were sent via a Bandwidth.Com service. Information was obtained that the **texts were sent from various states across the country, as well as from the Dominican Republic**. Bandwidth.com **does not authenticate the owners / users of the service**. No accurate identifying information was obtained to further the investigation. There is also a **popular scam** that has been taking place. **Investigation did not reveal any actual credible threat** to the victim or his family. This case is **closed**.

One (1) Theft was reported and investigated. In this case, a report was made that a **male stole several items from a Church** and the incident was observed on surveillance video. The **approximate value of the items stolen is \$100.00**. Through investigation, the **male was identified** and the **victim stated that he would accept restitution** in lieu of criminal complaints. The actor was provided an opportunity to make restitution. This case is currently **open and under investigation, pending the receipt of restitution**.

One (1) Suspicious Death Investigation case was reported and investigated. In this case, officers responded to a report of an **individual sleeping behind a business**. Upon arrival, the **individual was found to be deceased for an extended period of time**. The Bergen County Medical Examiner's Office responded to assist, as well as the Bergen County Sheriff's Department. During the investigation, there **did not appear to be any foul play** surrounding the victim's death. The **victim was transported to the Medical Examiner's Office, where an autopsy was performed** to determine the cause of death. The **death was ruled natural and no foul play** was discovered. This case is currently **closed**.

One (1) Identity Theft / Package Theft case was investigated. In this case, a report was made by a **victim who resided in North Bergen**. The victim reported that an **unknown person had used her information to make an online purchase of an iPhone** and it was **being delivered to a residence in Bergenfield**. Surveillance was set up and a 35-year-old male from the Bronx, NY responded and retrieved the package. The **male was arrested** and was also found in possession of numerous debit cards in other people's names. After further investigation, the **male was charged with (1) count of Theft, (5) counts of Receiving Stolen Property, and (1) count of Identity Theft on a Complaint Summons** and was released pending his appearance in Bergen County Central Judicial Processing Court. This case is **closed**.

June:

Three (3) Death Investigation cases were investigated. In the first case, a concerned family member requested a **welfare check** on a female. Officers responded and located the victim, who was **deceased**. During the investigation, **suspicious circumstances** were observed. The **Bergen County Medical Examiner's Officer responded to assist**. The victim was transported to the Medical Examiner's Office where an **autopsy would be performed**. This case is currently **pending, awaiting a cause of death and autopsy report** from the Medical Examiner.

In the second case, officers responded to a frantic call for a **possible suicide**. Upon arrival, officers located the **victim, who was deceased from an apparent self-inflicted gunshot wound to the head**. A **weapon was located** at the scene. During the investigation, **no foul play was observed or suspected**. The **Bergen County Medical Examiner's Office responded to assist**. The victim was transported to the Medical Examiner's Office, where an **autopsy would be performed**. This case is currently **closed**, as the death was ruled a **suicide**.

In the third case, officers responded to a call for a **possible suicide**. A family member reported that the victim appeared to have **committed suicide by way of hanging**. Upon arrival, officers **located the deceased male in the garage of the home**. During the investigation, **no foul play was observed or suspected**. The **Bergen County Medical Examiner's Office responded to assist**. The victim was transported to the Medical Examiner's Office, where an **autopsy was performed**. This case is currently **closed**, as the death was ruled a **suicide**.

Three (3) Fraud incidents were reported and investigated. In these cases, victims reported **attempting to rent a vacant residence online**, only to find out that the rental **agreements were fraudulent**. Victims responded to an online ad for the vacant property, were **provided with a fraudulent lease agreement**, and paid between approximately **\$1000.00 and \$1500.00** to rent the residence. These cases are currently **open and under investigation**.

Numerous Identity Theft cases were reported and investigated. In these cases, victims reported that they received notifications that unknown individuals had applied for NJ Unemployment Benefits utilizing their information. In all the cases, the victims were still employed. The information was forwarded to the NJ Attorney General's Office, who currently have an ongoing investigation involving these incidents, which are widespread and frequent. These cases are closed, as the NJ Attorney General's Office Task Force have taken over the investigations.

July:

Two (2) Burglary cases were reported and investigated. In these cases, the same business was targeted twice in a two-week period. During the first incident, an unknown actor entered the business by smashing the front glass door with several bricks. During this incident, the actor removed (8) E-Bikes, valued at approximately \$5400.00. During the second incident, an unknown actor attempted to gain entry using the same method (smashing the window with bricks), but the actor was unsuccessful at entry. No items were reported missing during the second incident. This case is currently suspended, pending any DNA hits from the CODIS Database.

Two (2) Shoplifting cases were investigated and closed by arrest. In these cases, the same female and male suspect and vehicle were involved. In both incidents, the female suspect entered the businesses and while the employee was distracted, proceeded to steal cartons of cigarettes from both establishments. The total amount of proceeds taken was approximately \$500.00. During the investigation, it was discovered that the same pair committed similar crimes in other jurisdictions. In a collaborative effort, the female, male and vehicle were identified and both actors were arrested and charged on Complaint Summonses with (3) counts of Shoplifting. The actors were served with their complaints at the Bergen County Jail, where they were being held on additional charges from surrounding jurisdictions. These cases are currently closed.

One (1) Endangering an Injured Victim incident was reported and investigated. During this incident, a group of juveniles were engaged in utilizing a vape device while on a break from summer school, which contained suspected marijuana / THC. Several minutes after partaking, a juvenile female fell ill and collapsed. A juvenile male actor, who provided the substance to the female victim, left the victim unattended and fled the area. The victim was eventually located and transported to the hospital for treatment. This case is open and under investigation.

August:

One (1) Burglary / Bias Crime case was reported and investigated. In this case, a neighbor reported damage to a vacant residence. Upon arrival, the house was observed to have extensive damage to the windows, doors and contents of the home. There was also Bias related graffiti located throughout the residence. Confirmation from the home owners was received that the residence was in normal condition approximately one week prior when they were there to pick up the mail. The Bergen County Sheriff's Office Crime Scene Unit responded to assist. Evidence was collected and submitted for examination. This case is currently open, pending DNA / Fingerprint results.

Two (2) Stolen Motor Vehicle cases were re-opened for investigation. In these cases, Detectives received CODIS "Hit" notifications that DNA samples taken from each of the stolen vehicles came back to a suspect, which already had DNA within the CODIS State Database. These cases are currently re-opened, pending further investigation and warrants/detainers for DNA comparisons.

Five (5) Theft from Motor Vehicle incidents were reported and investigated. In these cases, residents reported **damage to their vehicles**, which were parked overnight near their residences. Upon further inspection, it was observed that the **catalytic converters were cut from the vehicles**. On average, each catalytic converter repair is **valued at approximately \$1500.00**. These cases are currently **open and under investigation**.

One (1) Robbery incident was reported and investigated. During this incident, a resident reported that he **agreed to meet an individual from a Facebook Marketplace ad to sell a Sony PlayStation console**. Upon meeting the unknown male, a **struggle ensued** and the male suspect **took the gaming console** and fled the area. The **victim was not injured** during the struggle and **refused medical attention**. The **value of the stolen gaming console is \$550.00**. This case is **open and under investigation**.

September:

One (1) Bias Crime/Harassment case was reported and investigated. In this case, reports were made regarding a vehicle driving around with the **operator yelling derogatory / bias related comments** towards pedestrians. The **investigation is ongoing** and surveillance video is being obtained and reviewed in an **attempt to identify the suspect**. This case is currently **open and under investigation**.

One (1) Suspicious Incident case was reported and investigated. In this case, a pastor of a **local church** reported that he **received a suspicious package** in the mail, which **originated from Russia**. While examining the package, the pastor observed that the **package contained a suspicious crystalized substance**. The area was **cordoned off** and **Bergen County Hazmat, Bergen County Bomb Squad, and the Bergenfield Fire Department** were dispatched to assist. The suspicious substance was tested and deemed to be **non-hazardous, non-explosive, and was not a narcotic**. The **Department of Homeland Security and FBI** were also notified regarding the suspicious activity. This case is currently **open pending assistance/information from DHS and the FBI**.

One (1) Theft incident was reported closed by arrest. In this case, the owner of a business reported that an **employee was caught stealing** items while he was working. Through investigation, it was also revealed that the male not only was stealing products from the business, but **selling the stolen merchandise** to unsuspecting customers. It was also discovered that the suspect **unlawfully removed information from a computer database** during his activities. The **total value of the stolen merchandise** was approximately **\$800.00**. The male was ultimately **arrested and charged** on a Complaint Summons for **Theft, Fencing, and Computer Theft**. The male was **released pending his appearance** in Bergen County Central Judicial Processing Court. This case is currently **closed**.

One (1) False Public Alarm incident was reported and closed by arrest. During this incident, officers responded to an **activated fire alarm at the Bergenfield High School**. During the investigation, it was discovered that an **occupant of the building had activated a pull station** within the high school. Investigation revealed that there was **no fire or reason for the police and fire response**. The male was **eventually identified as an 18-year-old student**, who was ultimately **arrested and charged** on a Complaint Summons for **False Public Alarms**. The male was **released pending his appearance** in Bergen County Central Judicial Processing Court. This case is **closed**.

One (1) Theft, Fraud, Identity Theft was closed by arrest. In this case, a resident reported in March of 2021 that he never received a newly issued credit card in the mail. The victim realized this once he observed several unauthorized charges being made with the new credit card. The card was used to make numerous transactions in Jersey City, Irvington and Secaucus. The total amount of fraudulent charges was approximately \$1700.00. Through investigation and the assistance of Livingston PD, the male was identified. The male, whose whereabouts were unknown for approximately 6 months, was ultimately located by the US Marshalls Service and he was lodged in the Essex County Jail. The suspect was charged on a Complaint Warrant with Credit Card Theft, Fraudulent Use of Credit Cards, and Identity Theft. The male was served with his warrant at the Essex County Jail. This case is currently closed.

October:

One (1) Fraud / Theft by Deception case was reported and investigated. In this case, the victim was exiting a business and was solicited by two unknown actors for gas money in order to drive to Florida. The victim was deceived into purchasing jewelry, which was determined to be fraudulent. The victim paid the actors \$2050.00 to purchase the fake jewelry. This incident is consistent with a frequent "Gypsy Scam" which has been occurring in the tri-state area. This case is currently open and under investigation.

One (1) Aggravated Assault / Weapons Offense case was reported and investigated. In this case, officers responded to a late-night establishment on a report of gunshots that had been fired. Upon arrival, officers determined that no gunshots were fired and an unknown patron that was escorted from the establishment brandished a handgun while leaving the area. The patron was agitated that he was removed from the business. This case is currently open and under investigation.

One (1) Theft incident was investigated and closed. In this case, the owner of a business reported that several items, specifically several expensive coats, were stolen from the business while it was open to the public. The value of the stolen coats was approximately \$10,000. The owner was able to review surveillance cameras and recognized the male who took the coats as a frequent customer. Through investigation, the suspect was identified and the coats were recovered. The victim did not wish to pursue complaints against the actor, as the items were returned. This case is currently closed.

One (1) Suspicious Death incident was reported and investigated. In this case, officers responded to a report of an unresponsive person. Upon arrival, the male victim was discovered to be deceased. Evidence of narcotic use was present at the scene. There did not appear to be any foul play at the scene. The Bergen County Medical Examiner's Office responded to assist. The male victim was transported to the Medical Examiner's Office, where an autopsy would be performed. This case is currently open, pending the autopsy results.

November:

One (1) Identity Theft case was investigated and closed with complaints. In this case, the victim, who was an owner/operator of a trucking business, had his Department of Transportation (DOT) number stolen and it was fraudulently being used. The victim lost approximately \$80,000.00 in revenue due to the fraudulent activity. The crime was also reported to the New Jersey State Police (Commercial Enforcement Unit) and the Federal Motor Carriers Association. With the assistance of both agencies and through a 6-month investigation, a suspect from Illinois was identified. The male was charged on a complaint summons with 2nd Degree Identity Theft and the complaints were mailed to the last known address of the actor. This case is currently closed, pending the appearance of the actor in Superior Court.

One (1) Swatting / False Report case was reported and investigated. In this case, the Police Department received a call from an **unknown male who stated that he had just killed his parents and was armed with a gun.** Officers responded, along with the **Bergen County Regional SWAT Team** and ultimately, **the call was proven to be false.** The resident of the house where officers were dispatched to was not home at the time and was at work. This case is currently **open and under investigation.**

Four (4) Burglary to Motor Vehicle incidents were reported and investigated. In these cases, the owners of the vehicles reported that their vehicles had been entered during the overnight hours and items were stolen. All of the vehicle that were entered were left unlocked. **Items that were missing consisted of approximately \$1000.00 in cash, construction tools valued at approximately \$2000.00, and a Movado watch valued at \$1200.00.** Some of the incidents were captured on surveillance cameras. This case is currently **open and under investigation.**

One (1) Aggravated Sexual Assault incident was investigated and closed by arrest. In this case, a **12-year-old juvenile female** reported to school officials that she was the victim of **numerous sexual assaults** over the period of approximately 5 years. The **actor of the sexual assaults** was identified as the **victim's uncle.** With the **assistance of the Bergen County Prosecutor's Office,** the male actor was ultimately **located and arrested.** The male was **charged on a complaint warrant with (3) counts of 1st Degree Aggravated Sexual Assault, (1) count of 2nd Degree Sexual Assault, and (1) count of 3rd Degree Endangering the Welfare of a Child.** It was also discovered that the male actor was in the United States illegally, as he had **previously been deported in 2005.** An **ICE Detainer** was also placed on the male actor. The actor was **lodged in the Bergen County Jail** pending his appearance in Bergen County Superior Court. This case is currently **closed by arrest.**

December:

Six (6) Theft cases were reported and investigated. In each of these cases, the victims reported that **packages that were shipped and marked as delivered were missing from their residences.** The victims resided in various locations throughout the Borough. The time frames for the thefts varied. **The total value of all of the items stolen during these incidents is approximately \$2600.00.** These cases are currently **open and under investigation.**

Two (2) Burglary cases were reported and investigated. In these cases, **two businesses which were next to each other were burglarized during the overnight hours.** The unknown actor accessed the businesses by **forcing entry to the glass on the front of the buildings.** Some of the incidents were captured on surveillance cameras. **The items missing from both of the businesses amounts to approximately \$1700.00 in cash and \$350.00 in merchandise.** These cases are currently **open and under investigation.**

Two (2) Burglary cases were closed by arrest. In these cases (one from **September** and one from **November**), the actor **entered a business and stole approximately \$800.00 worth of scrap metal.** During the investigations and a third incident, the **actor was identified and tied to the previous two incidents.** The male was **charged on a complaint summons with (2) counts of Burglary, (2) counts of Theft, and (2) counts of Criminal Trespass.** The actor was scheduled to **appear in Bergen County Central Judicial Processing Court** for the charges. These cases are currently **closed.**

One (1) False Public Alarm / Terroristic Threat incident was **investigated and closed by arrest**. In this case, school officials were made aware of **threatening messages** that were **distributed by a 13-year-old male student**. The disturbing messages **detailed a school bombing / shooting**, which caused the school to be placed in a **lockdown**. The **male juvenile** was not present in school and was quickly **located and detained**. Through the investigation, it was determined that **there was no actual threat and no weapons / explosive devices were located**. The **Bergen County Prosecutor's Office and Bergen County Sheriff's Department K9 Unit** assisted during the investigation. The **juvenile male was charged on a Juvenile Delinquency Complaint with (1) count of False Public Alarm and (2) counts of Terroristic Threats** and was released to his parent. The juvenile male is **scheduled to appear in the Bergen County Superior Court Family Division**. This case is currently **closed by arrest**.

2. Miscellaneous Statistics for 2021:

During 2021, the Detective/Juvenile Bureau continued to face significant challenges due to not only a continued shortage of manpower (**vacant Detective Sergeant position for approximately 1 ½ years**), but the **continued growth of case load and assignments**. This continues to put **unnecessary strain** on the Bureau members. We also continue to face further shortages due to members being absent due to COVID-19.

Once again, the Detective Bureau faced another **15% increase in cases** (111 more than 2020) and we also observed **another 22% increase in Firearm Identification Card and Firearm Purchase Permit Application Investigations**, which increased for the Bureau approximately (65 more cases than 2020). We also had to navigate a **17% increase in assignments/details** throughout the year (449 more assignments/details than 2020).

Due to these unprecedented times, Bureau members are now carrying **40 plus cases each**, which is unheard of. The **average case load** per Detective prior to manpower shortages was **approximately 10-15 cases**. These circumstances have also caused a **backload of another 52 unassigned Firearm Identification Card and Firearm Purchase Permit Application Investigations**, which will carry over into the year 2022. It is important to note that **Firearm ID Card and Firearm Permit Application Investigations are a secondary responsibility** and are not handled full time. The priorities continue to be the investigations of the primary case load. An **increase in significant cases**, which require **multiple Detectives and hours of investigation**, also **contribute to the backlog**, which could simply be **avoided with the proper staffing**.

During **2021**, the Detective/Juvenile Bureau also carried out **two thousand six hundred and forty-four (2644) other assignments/details and calls for service**:

Detectives made a total of **ten (10) Court appearances (virtual or in person)** at the Bergenfield Municipal Court, Grand Jury and Juvenile Court. Detectives participated in **one hundred sixty-three (163) Transportations** that included bringing indictable cases to the Grand Jury Pre-Screening Unit of the Bergen County Prosecutor's Office, delivering evidence to the NJ State Police Lab in Little Falls for forensic examination, delivering and picking up evidence from the Bergen County Sheriff's Department BCI and Bergen County Prosecutor's Office, as well as other various in town and out-of-town locations for police related business. The Detective Bureau also completed **forty-seven (47) Sex Offender registrations (or re-registrations)**.

The Detective Bureau **Assisted Patrol** officers on **seven hundred and forty-one (741) occasions**, **Assisted other agencies** on **five hundred and sixty-six (566) occasions** and **Assisted Bergenfield residents and other civilians** with non-criminal matters on **six hundred and forty-four (644) occasions**. Some of these other agencies included the Bergen County Prosecutor's Office Arson Investigation Squad, the Division of Youth & Family Services (DYFS), NJ State Parole, BC Probation Department and Juvenile Probation, BC Sheriff's BCI Unit, the Bergenfield Community Outreach, Englewood, Teaneck, Tenafly, New Milford, and Dumont Police Departments.

Detectives also conducted **surveillances and/or checks** at Borough parks, Coopers Pond, the library, areas of Howard Drive/Georgian Ct, and within the borough's business districts to deter acts of narcotic use, graffiti, public alcohol consumption, littering and other illegal acts. **SNAP** was conducted on **one hundred three (103)** occasions at the schools in Bergenfield. **Fingerprint Services** were conducted on **one hundred ninety-two (192)** occasions. **Fifty-six (56)** Peddler **Background Check** Investigations were conducted. A total of **eighty-seven (87)** employee/volunteer background checks/investigations were conducted. These include checks on potential **Borough employees, DPW summer help, Bergenfield Fire Department and Bergenfield Ambulance Corp. volunteer** applicants and **Police Officer** Background checks for applicants.

Twenty-one (21) arrests were also issued/conducted. **Two hundred and ninety-one (291)** Firearms background checks were completed for **applications to purchase handguns and Firearms ID cards**.

3. Juvenile Bureau Statistics for 2021:

During **2021**, members of the Bergenfield Police Department Juvenile Bureau handled **fifty (50) Referrals**. These referrals include **two (2) Juvenile Complaint Referrals** and **forty-eight (48)** Referrals for the Juvenile Bureau requesting either assistance with **non-criminal family matters**, or where **delinquency** was addressed **without Juvenile Complaints**.

Regarding the above-mentioned referrals, they were handled in any one of the following ways:

Deputy Chief's Annual Report 2021

Since the date of my last report until his cancellation in June of 2021, Governor Murphy had declared a State of Emergency due to Covid-19. In July, 2021, Covid-19 Delta Variant emerged as the dominant strain, causing a surge in infections throughout the Country. Due to the aforementioned, this year has been a very difficult year for policing and this needs to be accounted for while reviewing the year. Policing has been much more reactive rather than proactive as face to face encounters have been minimized.

Administration

Currently, we are operating at full capacity.

Patrol

In the past year, we have operated at a manpower shortage due to one suspension and numerous members of the Department being out on injury, illness, family leave, military leave and the failure to replace officers that have left over the past year/retiring from the department.

Currently, two of the squads are working with 6 officers and two of the squads are working with 5 officers. This along with Contractually allowable time off and sick leave are affecting the flexibility with assignments, such as training and directed patrol.

Officers are checked monthly by their supervisors and all are working with the required equipment. Due to Covid-19, Patrol Officers have made few self-initiated arrests and traffic enforcement has diminished significantly, resulting in fewer summonses than past years. As the population receives more vaccinations and we move toward herd immunity and the dangers to officers diminish, we will be implementing strategic operations and directed patrols to assist in pedestrian safety efforts and traffic enforcement.

In December 2020, two officers were hired. Both have successfully completed their Field Training and are on Active Duty. Uniforms, equipment and body armor were purchased for all in compliance with their contract.

Detective Bureau

Currently, we are not operating at full manpower. The Detective Sergeant position has been vacant since mid-2019. The juvenile Detective who was brought into the DB in 2019 has been trained and is working with full confidence. Once the Bureau is fully staffed, I expect the Bureau to address many of the quality of life issues facing the Borough and an increase in enforcement. The Bureau has been able to work in conjunction with the Patrol Division and other agencies to make numerous narcotic arrests and continues to work on cases and investigations with the utmost attention. A Detective is on loan to the DEA and has been involved in numerous arrests/seizures resulting in federal forfeiture funds being allocated to the Department. Detectives are working to complete Background Checks on numerous applicants for Police Officer.

Field Training

The Field Training Program is currently being supervised by Lt. Ramos. We are currently preparing for candidates that are scheduled to be hired in the near future and will enter into the Field Training Program.

Traffic

We have been operating without a Traffic Lieutenant, due to manpower shortages since Captain Maggi was promoted in 2019. The Division conducts Limo inspections, child car seat installations, coordinates all borough functions, such as parades, ceremonies, etc. The Traffic Division oversees the hiring / training of crossing guards (22 in total). The Traffic Division also oversees the hiring / training of the auxiliary police (20 in total). The Traffic Division vigorously explores opportunities for grants awarded for pedestrian safety, distracted driving and drive sober or get pulled over. The Traffic Officer was utilized to ease manpower shortages in the Patrol Division on numerous occasions.

Records

The Records division is operating at a full manpower consisting of a Lieutenant and an Officer. From the beginning of the year until this date, we have retrieved 268 pounds of unused/unwanted medicine

slated for disposal. The Records Bureau coordinates/maintains all technology for the Department. The Officer of Records was utilized to ease manpower shortages in the Patrol Division on numerous occasions.

Drunk Driving Enforcement Fund (DDEF)

Due to pandemic resulting in short staffing/retirements, we have not received the DDEF Application for this year, however the award was posted earlier this year. This award is to be used for enforcement details and equipment purchases for DWI enforcement.

Bullet Proof Vest Funds (BPVF)

All Police Officers have either been supplied with Bullet Proof Vests from the Department or are currently utilizing vests from their previous employers.

In 2021, we ordered 14 vests, for the 2 new hires and officers whose vests expired and were in need of new vests. The officers are awaiting the arrival of their vests. Several officers will need vests in 2022 as their vests will be expiring.

We have two different BPV Funds, the state and the federal funds. There are different rules and requirements that must be met for each of these funds. I was able to apply for the State Fund Grant and the award is \$3,569.14 for 2020 and the 2021 application was completed. I was able to apply for the Federal Grant and the award is pending approval for 2021. The Federal Grant is a matching fund.

Equipment Tracking

All new officers have been supplied with equipment/uniforms in compliance with their contract.

Lieutenants in charge of each Bureau of the Department conduct monthly and random line inspections to make sure that all officers are outfitted with the proper equipment and to identify any equipment needs.

Currently all equipment is operationally ready.

Active Shooter


We are tentatively scheduled to conduct Active Shooter Training for the entire Department in November 2021. Our Active Shooter Training Officers continued with in-service training as opportunities were

available. We will continue with Active Shooter Training both, Department wide and individually in the next year.

Motor Vehicle Enforcement

From the beginning of the year through September, Officers issued a total of 940 motor vehicle summonses: 491 for moving violations and 449 for parking violations.

MONTHLY REPORT

DECEMBER 2021

PATROL BUREAU

Members of the Patrol Bureau responded to a total of three thousand three hundred and two (3,302) **Calls for Service** for the month. They effected nine (9) **Arrests** for Criminal, Motor Vehicle Offenses and/or active FTA-Traffic/ACS Criminal Warrants.

Patrol Officers also investigated fourteen (14) **Domestic Violence** incidents and one (1) **Incident of Criminal Mischief**. There were three (3) **Burglaries** reported, one (1) **Motor Vehicle Theft** and seven (7) other **Thefts** reported.

There were no (0) **Missing Person** reported to our Department. Preliminary investigations were conducted for eleven (11) **Identity Theft/ Fraud** cases. They also completed twenty-one (21) **Resident Welfare** checks, sixty-two (62) requests for **Assistance** and five (5) requests to make **Notifications** to residents.

Patrol Officers issued a total of one hundred and fifty (150) **Summonses** for Motor Vehicle Violations. They had eight (8) vehicles **Impounded** for violations.

Officers responded to and completed crash reports for fifty-eight (58) **Motor Vehicle Crashes**. They also had one hundred and forty-five (145) requests for **Medical Aid**, and nine (9) **Mental Health** matters. There were fifty-three (53) **Alarm Activations** and fifty-nine (59) reports of **Fire**.

Additionally, Patrol officers responded to and investigated sixty-five (65) **Suspicious Incident** calls, forty-four (44) **Dispute/Harassment** calls, eight (8) **Noise Complaints/Other Disturbance** calls, fourteen (14) **Animal Complaints** (loose animal, animal bite) calls, six (6) **Utility Emergency** calls and conducted four (4) **Escorts**.

All Officers continued **Security Checks** and walk-throughs of all schools, parks, banks and businesses within the Borough.

The Traffic Bureau held its monthly training meeting of the Auxiliary Police at PHQ. half of the Auxiliaries responded to the BVAC building for CPR training. The remaining Auxiliaries will complete the CPR training in the near future.

The Traffic Bureau assisted with a funeral procession from Dumont to Bergenfield.

The Traffic Bureau attended the Holiday Lights Parade meeting at Prospect Fire House and set up Auxiliaries and Patrol to assist with the event.

The Traffic Bureau monitored/assisted with traffic at the elementary schools during morning drop off.

The Traffic Bureau / Chief Rabboh attended a virtual meeting with Smart Streets to discuss programs we will be participating in during 2022.

The Traffic Bureau conducted tow yard inspections for the 2022 Towers and completed all paperwork.

A member of the Traffic Bureau coordinated the insurance claim for a police vehicle that was damaged in a motor vehicle crash.

A member of the Traffic Bureau again met with Ridgetop, the contractor at Hickory Manor, and assisted Ridgetop with the second delivery of prefabricated units for Hickory Manor.

A member of the Traffic Bureau conducted 4 child safety seat installations for residents of the town.

A member of the Traffic Bureau performed a limousine inspection for a borough company.

A member of the Traffic Bureau conducted directed patrol and radar enforcement in various areas in the borough.

As in the past, the Traffic Bureau continues to coordinate traffic safety details for utility companies (NJDOT, PSE&G Gas, PSE&G Electric, CSX, Suez, Altice, Atlantic Infrared, Marini Brothers, Jo-Med and Verizon) performing work in the roadways and railroad.

Bergenfield Detective/Juvenile Bureau Monthly Report

December 2021

During the month of *December* members of the Detective/Juvenile Bureau were assigned *fifty-three (53) case investigations*

During the month of December, the Detective/Juvenile Bureau investigated several major cases:

Six (6) Theft cases were reported and investigated. In each of these cases, the victims reported that **packages that were shipped and marked as delivered were missing from their residences.** The victims resided in various locations throughout the Borough. The time frames for the thefts varied. The **total value of all of the items** stolen during these incidents is **approximately \$2600.00.** These cases are currently **open and under investigation.**

Two (2) Burglary cases were reported and investigated. In these cases, **two businesses which were next to each other were burglarized during the overnight hours.** The unknown actor accessed the businesses by **forcing entry to the glass** on the front of the buildings. Some of the incidents were captured on surveillance cameras. The **items missing from both of the businesses amounts to approximately \$1700.00 in cash and \$350.00 in merchandise.** These cases are currently **open and under investigation.**

Two (2) Burglary cases were closed by arrest. In these cases (one from **September** and one from **November**), the actor entered a business and stole **approximately \$800.00 worth of scrap metal.** During the investigations and a third incident, the actor was identified and tied to the previous two incidents. The male was **charged** on a complaint summons with **(2) counts of Burglary, (2) counts of Theft, and (2) counts of Criminal Trespass.** The actor was scheduled to appear in **Bergen County Central Judicial Processing Court** for the charges. These cases are currently **closed.**

One (1) False Public Alarm / Terroristic Threat incident was investigated and closed by arrest. In this case, school officials were made aware of **threatening messages** that were **distributed by a 13-year-old male student.** The disturbing messages detailed a **school bombing / shooting,** which caused the school to be placed in a **lockdown.** The **male juvenile** was not present in school and was quickly **located and detained.** Through the investigation, it was determined that **there was no actual threat and no weapons / explosive devices were located.** The **Bergen County Prosecutor's Office and Bergen County Sheriff's Department K9 Unit** assisted during the investigation. The **juvenile male was charged on a Juvenile Delinquency Complaint with (1) count of False Public Alarm and (2) counts of Terroristic Threats** and was released to his parent. The juvenile male is **scheduled to appear in the Bergen County Superior Court Family Division.** This case is currently **closed by arrest**

During the month of **December**, the Detective/Juvenile Bureau also carried out **two hundred fifty (250)** other **assignments/details and calls for service:**

The Detective Bureau **Assisted Patrol** officers on **sixty-eight (68)** occasions; **Assisted other Agencies** on **forty (40)** occasions. Some of these other agencies included the Bergen County Prosecutor's Office Sex Crimes Unit, the Division Child Protection and Permanency (formerly DYFS), NJ State Parole, BC Probation Department and Juvenile Probation, BC Sheriff's BCI Unit, the Bergenfield Community Outreach, and the New Milford Police Department. Members of the Detective/Juvenile Bureaus also **Assisted Bergenfield residents and other civilians** with non-criminal matters on **sixty-five (65)** occasions.

Detectives offered **Fingerprint services** on **ten (10)** occasions. Detectives participated in **ten (10)** **Transportations** that included bringing indictable cases to the Grand Jury Pre-Screening Unit of the Bergen County Prosecutor's Office, delivering evidence to the NJ State Police Lab in Little Falls for forensic examination, delivering and picking up evidence from the Bergen County Sheriff's Department BCI and Bergen County Prosecutor's Office, as well as other various in town and out-of-town locations for police related business.

Detectives also conducted several **Surveillances and/or checks** at Borough parks, Coopers Pond, the library, areas of Howard Drive/Georgian Ct, and within the borough's business districts to deter acts of narcotic use, graffiti, public alcohol consumption, littering and other illegal acts. **Five (5) Special (confidential) investigations** (following narcotics tips) are presently being conducted.

Detectives also attended meetings for the East Bergen Detective Group, BC Gang Task Force meeting and the BC Juvenile Officer's Association. Members also filed their **monthly reports for Detective and Juvenile Bureau statistics and UCR.**

Mrs. Pfannen stated that she attended a meeting with Mr. Gallo, Councilman Deauna, President Cheriyan and Ms. August to introduce Jim Fedorko, the new Health officer for Mid-Bergen Regional Health Commission.

Written Reports of the Department

Ms. August reported that the Moderna clinic held this evening, November 10th was successful, Ms. August also reported that she expects to get the Pfizer vaccine shortly along with the formulation for children 5-11. Ms. August stated that she is in communication with the nurses that have volunteered for past clinics and ensuring they will be available for future clinics.

A conversation took place regarding vaccine storage guidelines and also the process of documenting children 5-11 who will be receiving the vaccine. A discussion took place regarding vaccination data input which included but not limited to possibly hiring an intern and use Awarded State Grant Money that will be allocated for Bergenfield, reach out to IT students, and office staff that may be available so the data can be input in a timely fashion.

Kayla Williams reported on a food establishment in town that has been in constant violations. Ms. Williams stated that a final court appearance took place today with the establishment and, although there seemed to be some settlement, it is still an ongoing situation with many problems. Ms. Williams reported that in spite of the many summonses issued for different violations, the establishment is still not in compliance. A conversation took place regarding how to move forward to have the establishment be in compliance and ensure the safety of the residents. Mr. Fedorko stated he will discuss the situation with Ms. Williams and report back to the Board.

Mr. Fedorko stated that State-Wide rate of transmission for COVID related illness decreased for the month of October. Mr. Fedorko stated that there were 119 confirmed COVID-19 positive cases in Bergenfield for the month of October. A review of the most recent positive cases found that individuals were still testing positive despite being vaccinated.

Mr. Fedorko spoke on the 54 reportable communicable diseases in Bergenfield from January 1st to October 31st, 2021 such as Hepatitis B, Hepatitis C, Food Borne Illness and Lyme disease. Mr. Fedorko thanked Ms. August for following up on all the above mentioned cases.

Mr. Fedorko reminded the Board that the money allocated for Bergenfield from the State awarded grant should be received soon and can be used for costs incurred throughout the COVID-19 Pandemic. The grant money can be used for equipment or salary to hire an intern for data input if necessary.

President Cheriyan thanked Mrs. Williams for sending the COVID-19 activity report weekly to keep them informed.

A motion was made by Mrs. Pfannen seconded by Mrs. Marte and carried that the written October 2021 reports of the Department be accepted as written.

1. Budget 2022

Mrs. Williams reported that the budget meeting for 2022 has not been scheduled at this time and she will let the Board know when a date is set. Mrs. Williams also stated that the Health Department employees will submit an increase proposal to the Board for when they meet with Mr. Gallo.

2. Contracts 2022

Mrs. Williams reported that the yearly contracts for 2022 are being submitted to the Health Department. Mrs. Williams is asking permission from President Cheriyan to sign them on his behalf unless there is a significant change from 2021. President Cheriyan agreed. Mr. Fedorko stated that Mid-Bergen has two contracts being prepared for review by the Board for 2022 that he will submit as soon as they are finalized. One contract will include the R.E.H.S. to provide 4 days of service to the Borough and the second contract will include the R.E.H.S. to provide 5 days of service to the Borough. Mrs. Pfannen stated that since the Board passed an ordinance last year to inspect Nail/Hair Salons, it may be necessary to have the fifth day of service to allow for the additional inspections. Mr. Fedorko stated that Bergenfield is a big town with many food establishments that need priority based on risk levels. Mr. Fedorko will submit the contracts for review.

VERBAL COMMUNICATION

Mrs. Williams attended the Department Head meeting and reported on the following which include but not limited to construction on new building is scheduled to start late November, the parking situation for the employees and residents is being discussed, COVID testing for employees not vaccinated will begin November 1st, 2021. Anyone not vaccinated will need to be tested weekly.

Mrs. Williams stated that Mrs. Pfannen's term as Board of Health member will expire on December 31, 2021. Mrs. Pfannen agreed to be reappointed effective January 2022 for 4 years.

There being nothing further to come before the Board, on a motion by Mrs. Pfannen seconded by Mrs. Marte and carried, the meeting was adjourned at 7:50PM.

November 2021 Report of the PHN Supervisor

Communicable Disease:

Tuberculosis Control: Bergen County Chest Clinic staff and the Bergenfield nurses assist with case management as needed.

Tuberculosis Skin Test Screening: Two residents requested testing for employment mandates.

Reportable Laboratory Report Case Management: Please review attached CDRSS query on PHN activities.

Child Health Clinic: Dr. Nancy Rothenberg, DO examined seven children for developmental benchmarks and growth and development parameters. The PHN administered a total of 14 disease preventing vaccines during this clinic.

School Age Child Clinic: This Nurse lead clinic examined a total of seventeen school aged children prior to vaccination. A total of twenty-six disease preventative vaccines were administered.

Adult Vaccination Clinic: Fourteen residents received a total of fourteen disease preventive vaccines at their request.

Seasonal Flu Vaccination for Adults: Residents are seen by appointment. Seasonal influenza vaccines have been supplied at no cost from the federal government in response to the pandemic.

Covid Vaccine Clinics: Two Covid -19 Vaccination Booster Clinics were held by the Bergenfield Health Department. Moderna vaccine boosters were given on November 18th at Conlon Hall venue. A clinical outreach was held at the Bergenfield Senior Center located at Murray Hill Terrace on November 23rd.

Covid-19 Surveillance: Ongoing. Contact tracing is assigned daily. Supervisor review of case follow up and statistical compilations is forwarded daily to health officer. It is to be noted that case reports for positive cases are escalating. Most new cases are in the age 18-64 age group. Daily telephone guidance was attended to by this nurse 24/7 from Educational departments and local businesses concerning any need for quarantine. This nurse monitors weekly if Health Department staff are being tested for Covid 19 Disease.


Home Vaccination visits: Covid -19 vaccines have been given to seven home bound residents this month. Two residents requested the seasonal flu vaccination as well.

Other:

- Family Care representative has returned during Children's clinics. The representative assists families to obtain affordable health insurance. The Bergenfield Health Department has offered this service in the past. However, due to Covid-19 it was suspended till now. Children are seen at our vaccine clinics when the family has no health insurance. Most times this is due to fear of applying for insurance or inability to navigate the computer system. The Representative is a state worker who does not endorse one brand of health insurance. Rather he expedites the application process for families and answers questions.

Health Officer's Report November 2021

December 15, 2021

COVID-19

A review of the confirmed COVID-19 positive cases in Bergenfield from November 1st to November 30, 2021 was conducted:

A total of 864 people were tested for COVID-19 and 100 were positive.

The number of new cases of COVID-19 has been steadily increasing in Bergenfield since late summer. The number of new cases of COVID-19 is not only increasing in Bergen County but also throughout the State. Attached is the most recent COVID-19 Activity Level Report.

Total number of cases in Bergenfield from the beginning of the pandemic, March 1, 2020 is approximately 4,011. An estimated COVID-19 case fatality rate in Bergenfield is 1.6%.

Overall, the bad news is the number of new COVID-19 cases is increasing and about 40% to 60% of the people who recently contracted COVID-19 are fully vaccinated based on my calculations. The good news is that there are fewer hospitalizations and fewer deaths compared to last year.

Bergenfield has high vaccination rates compared to Bergen County and the State. See attached page 10. Vaccination rates by age are found on page 13. However, I think that the numbers are not accurate for Bergenfield.

Statewide:

NJ State-wide rate of transmission of COVID-19 is increasing and COVID related deaths are decreasing. See attached graph

The Delta COVID-19 Variant is still the most common strain of the virus circulating in NJ (98.8% as of November 27th). See attached report, page 1.

Influenza:

The current influenza activity level in NJ is listed as Moderate as of December 4, 2021. So far, we are experiencing a typical influenza season.

Health Officer's Report December 2021

January 10, 2022

COVID-19

The last COVID-19 related death in Bergenfield was on December 28, 2021 and tested positive for COVID-19 on 12/19/2021. The person was 72 years old and has no record of vaccination. The two most recently recorded COVID-19 related deaths in Mid Bergen's jurisdiction were the following: Englewood COVID related death on 1/5/2022 and tested positive on 12/29/2021. The person was vaccinated with Pfizer on 4/16/2021, 5/7/2021, and 11/22/2021. Leonia COVID related death on 12/28/2021; tested positive on 12/14/2021 and has no vaccination record.

There were 901 confirmed COVID-19 positive cases in Bergenfield from December 1st to 31st. See attached tables for 2020 and 2021 comparisons.

As of January 3, 2022, Bergenfield has an 86% COVID-19 fully vaccinated rate (age 5 and older) and 42% of the population received a booster/3rd dose vaccine.

The rate of transmission of COVID-19 in Bergenfield has increased approximately seven times from the month of November. The number of new cases went from 127 new cases to 901 new cases. In New Jersey, the COVID rate of transmission began expanding in mid-November and the rate of transmission began to increase in Bergen County in late November.

The most recent COVID-19 Variant Surveillance Report, Week ending December 25th, indicates that 76.2% of infections in NJ are the Omicron variant while 22.0% are the Delta variant. See attached report.

The CDC has the following information posted on their web page: "Data from South Africa and the United Kingdom demonstrate that vaccine effectiveness against infection for two doses of an mRNA vaccine is approximately 35%. A COVID-19 vaccine booster dose restores vaccine effectiveness against infection to 75%."

The percent of inpatient beds occupied, and the percent of ICU beds occupied in New Jersey hospitals increased in December from the previous months. However, New Jersey hospitals are not at a critical stage. Inpatient beds were at 70.2% occupied and ICU beds occupied were at 47.1% in December.

Influenza:

Influenza activity level is high statewide and there have been no influenza-associated confirmed pediatric deaths reported this season. The Influenza and Respiratory Illness Surveillance Report was sent to the Board via email.

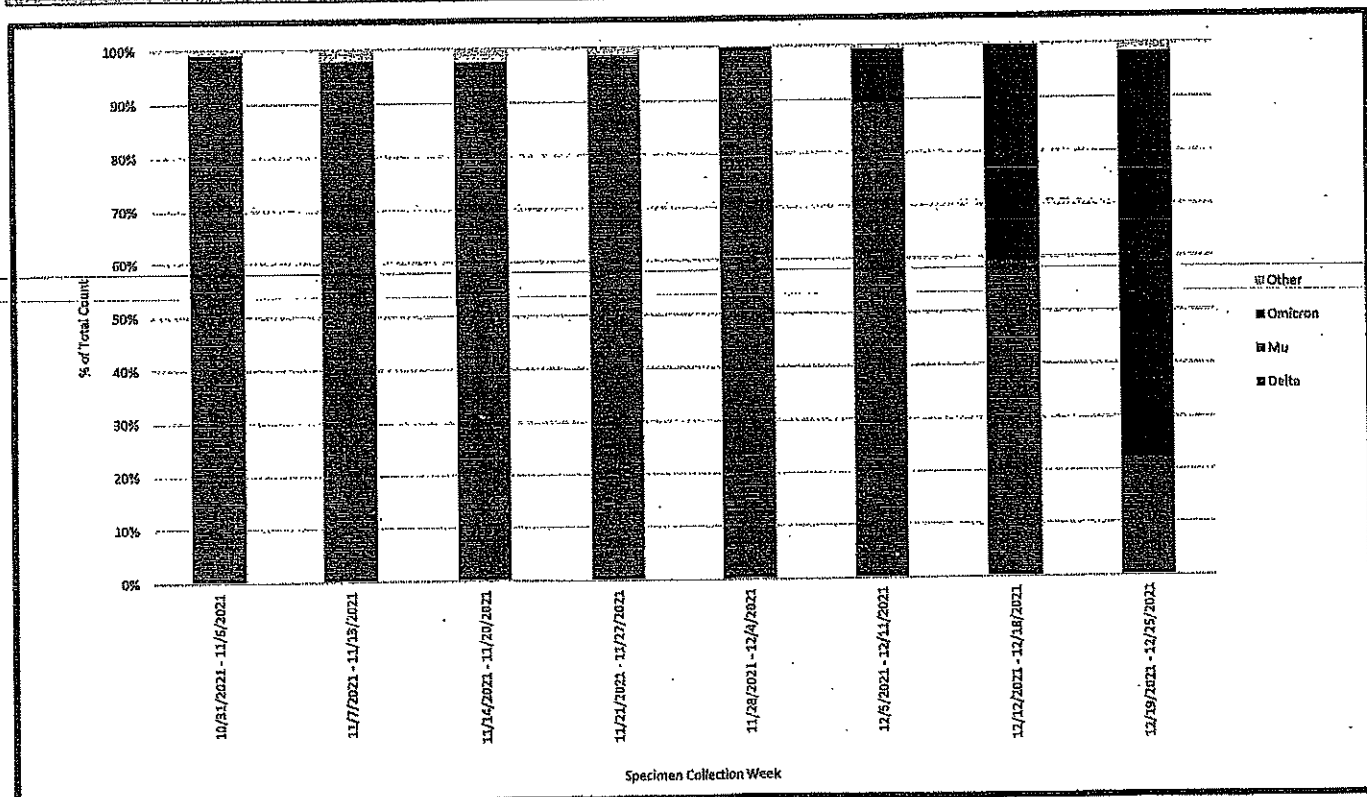

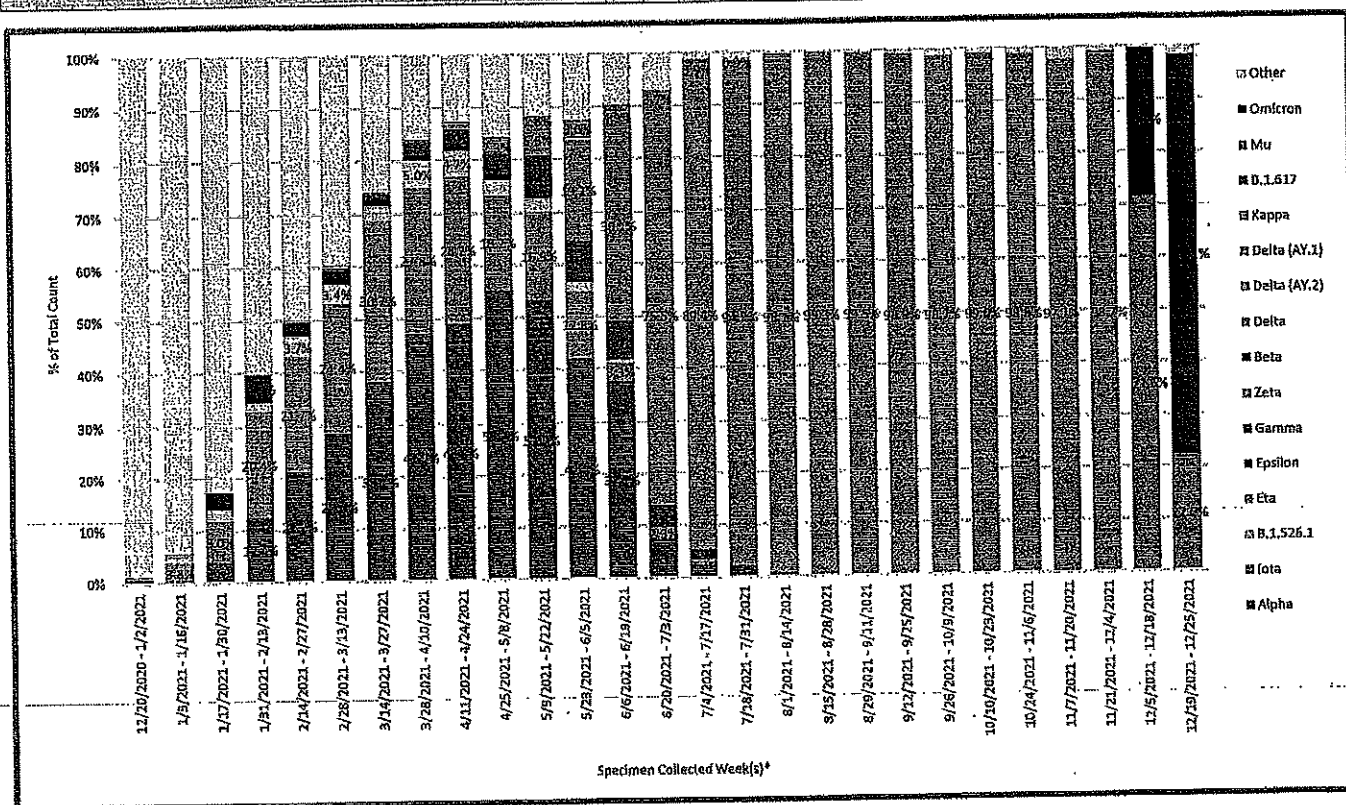

COVID-19 Variant Surveillance by Specimen Collected Week - Cumulative Summary



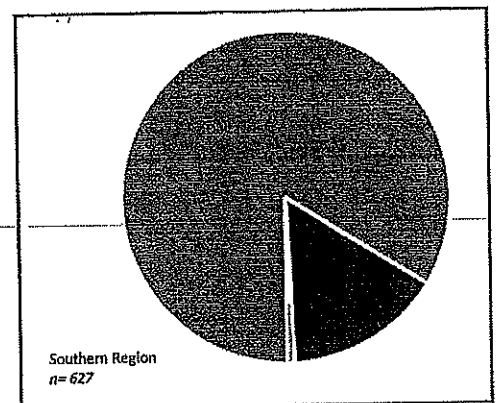
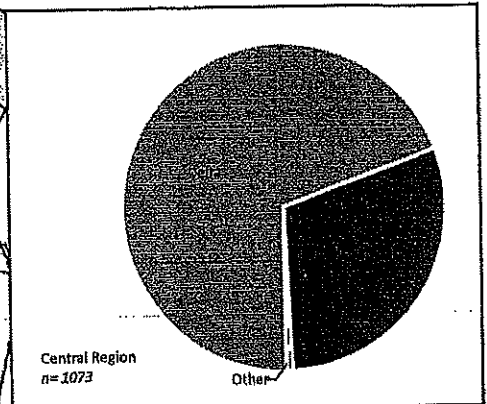
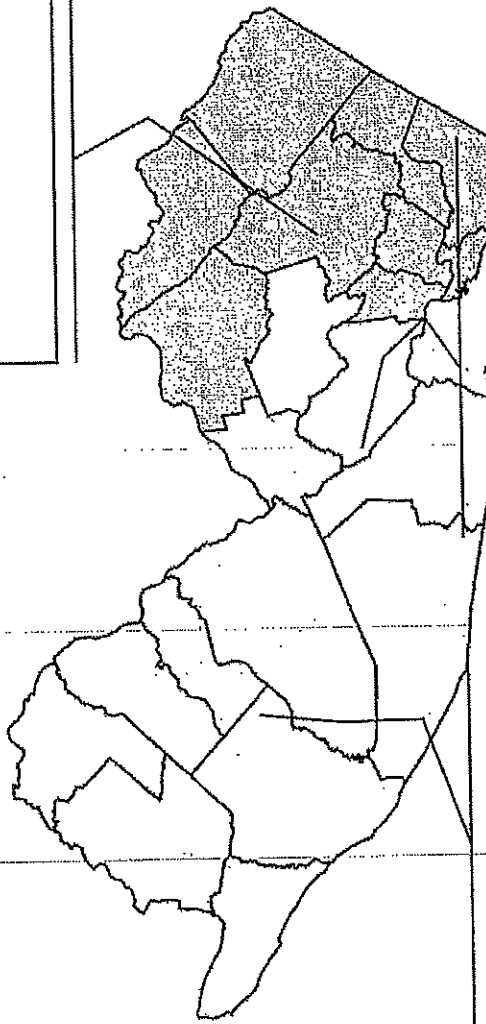
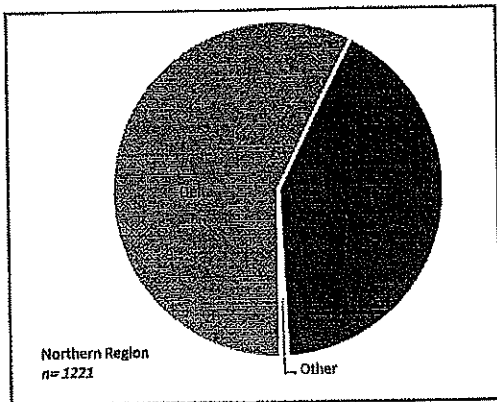

President's Report

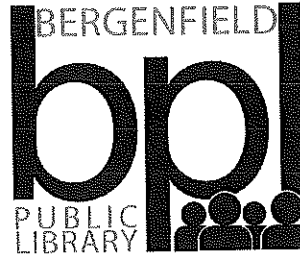
