## AN ORDINANCE AMENDING CHAPTER 17 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED "POLICE DEPARTMENT"

**WHEREAS,** Chapter 17 of the Code of the Borough of Bergenfield sets forth all regulations regarding the Police Department within the Borough of Bergenfield; and,

**BE IT ORDAINED**, by the Mayor and Council of the Borough of Bergenfield, County of Bergen and State of New Jersey that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged.

#### ARTICLE II.

#### Sec. 17-18. Special Law Enforcement Officers III.

A.Upon the recommendation of the Police Chief, the Mayor shall have the power to appoint, with the approval of the Borough Council, Special Law Enforcement Officers III (SLEO III"), as School Security Officers for the Bergenfield School District. The SLEO III's shall be in the form of retired police officers provided by the Bergenfield Police Department. SLEO III's shall receive such compensation as the Borough Council shall determine by ordinance. All SLEO III's shall work under the direction of the Chief of Police.

B. All SLEO III's shall meet the qualifications as outlined in <u>N.J.S.A</u>. 40A:14-146.10.

<u>Severability.</u> All provisions of this Ordinance are severable. If for any reason, any provision of this Ordinance is held to be invalid, the validity of the remainder of the Ordinance shall not be affected.

<u>Effective Date</u>. This Ordinance shall become effective upon final approval and publication, pursuant to law, and upon completion of all outstanding cases.
