## AN ORDINANCE ENTITLED "VACATING AND TERMINATION OF SANITARY SEWER EASEMENT"

WHEREAS, the purpose of this Ordinance is to Vacate and Terminate a Sanitary Sewer Easement located at Block 87, Lot 1 in the Borough of Bergenfield.

WHEREAS, on October 15, 1990, a Deed for Sanitary Sewer Easement was entered into wherein C.B.I. Inc. granted to the Borough of Bergenfield a ten (10') foot sanitary sewer easement on property located at Block 87, Lot 1; and

WHEREAS, the referenced property is the subject of land use development approvals by Landmark Equities LLC for the construction of a multi-family residential project in the Borough; and

WHEREAS, as part of the development approval, the Borough agreed to terminate and abandon the existing ten (10') foot sanitary sewer easement previously granted to it; and

WHEREAS, as the sanitary sewer easement no longer serves a municipal function, it is necessary to vacate and terminate the sanitary sewer easement located on the property now owned by HR Bergenfield LLC known as Block 87, Lot 1 in the Borough and more specifically described on the Legal Description of the easement area annexed hereto and made a part hereof.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Bergenfield, County of Bergen and State of New Jersey that Ordinance \_\_\_\_\_ entitled "Vacating and Termination of Sanitary Sewer Easement" of the Code of the Borough of Bergenfield, is hereby established and adopted as follows:

### Sec. -1 Findings.

The Borough of Bergenfield hereby agrees to vacate and terminate the sanitary sewer easement located in Block 87, Lot 1 in the Borough of Bergenfield and more specifically described on the legal description of the easement area attached hereto.

#### SEVERABILITY

All provisions of this Ordinance are severable. If for any reason, any provision of this Ordinance is held to be invalid, the validity of the remainder of the Ordinance shall not be affected.

#### EFFECTIVE DATE.

This Ordinance shall become effective upon adoption, final approval and publication, pursuant to law.
